IMPORTANT INSTRUCTIONS

Entry Class – Nursery

Session 2026-27

1. Only those children who complete **3 years of age as on March 31, 2026** i.e. children born between April 1, 2022 to March 31, 2023 (both days inclusive) will be eligible for admission to Nursery (Entry Class) for the academic session 2026-27. If the child is **not** within the age limit specified above, she / he will not be considered for the Admission.
2. Rs. 150/- will be charged as registration fee at the time of submission of registration form. **Registration Fee is non- refundable. The submission of form does not guarantee admission in any way. Parents are requested to clarify the doubts if any, before paying the registration fee.**
3. Application form duly filled along with the relevant documents will be accepted only from **9th December 2025 to 22nd December, 2025 from 9:00 a.m. to 11:30 a.m. & 12:00 noon to 2:00 p.m.** No form will be accepted under any circumstances **after 2:00 p.m. on 22nd December, 2025**
4. Selection will be made by '**DRAW OF LOTS**' – Under the observation of '**OBSERVER**' deputed by **District Education Officer, U.T. Chandigarh.**
5. Admission for the following categories are reserved-
 - (a) Wards of Ankur School Staff
 - (b) Wards of Alumni- Wards of students who passed from Ankur School, Panjab University Campus Sector-14, Chandigarh (Please attach the proof).
 - (c) Twin Cases (**In twin cases, if one sibling is selected the other will be given admission automatically.**)
6. Draw of lots for the wards of Panjab University employees will be held first, followed by the wards of Non University employees.
7. If the name and surname given in the registration form do not match with the birth certificate of the child, the registration form will be considered invalid/ incomplete and **will not be considered** for the DRAW OF LOTS.
8. No alteration will be permitted in the registration form once the same has been submitted. Hence you are strongly advised that the necessary rectifications like addition/ deletion of the name/surname/parent's name should be done legally from the Issuing Authority **before** submission of the Registration Form.
9. At any point In case it comes to the knowledge of the Management that the information furnished is incorrect or wrong, the admission will stand **cancelled** without the applicant having any **right to claim for the refund of the fee paid.**
10. **Incomplete Forms/ filled with incorrect information/unattested certificates not attached with all the required documents, will not be considered for the DRAW OF LOTS. All the certificates attached with the form should be self attested, by either of the parents.**
11. **Only ONE** application form per child will be accepted.
12. **Please Note:** - The school does not take responsibility of providing transport facilities for the selected candidates. Parents are responsible for the same. However, there are a few private contractors plying buses for the school under an agreement with the school. Students may avail the bus facility depending on the availability of the seats. Bus routes will not be changed to suit the individual's convenience. Parents are advised to take admission in schools near their residence. It will be the responsibility of the parent/ guardian to drop and collect the child from the specified bus-stop. It will be the responsibility of the parents to choose the safest mode of transport for their wards.
13. Registration/ **DRAW OF LOTS** does not guarantee admission. The admission process will be considered complete only after all the formalities of the admission and payment of the fee is done within the stipulated time.
